

# Agree Realty Declares Monthly Cash Dividend

BLOOMFIELD HILLS, Mich., Feb. 11, 2021 /PRNewswire/ -- Agree Realty Corporation (NYSE: ADC) (the "Company") today announced that its Board of Directors has authorized, and the Company has declared, a monthly cash dividend of \$0.207 per common share. The monthly dividend reflects an annualized dividend amount of \$2.484 per common share, representing a 6.2% increase over the annualized dividend amount of \$2.340 per common share from the first quarter of 2020. The dividend is payable March 12, 2021 to stockholders of record at the close of business on February 26, 2021.
