

Agree Realty Declares Quarterly Cash Dividend

The dividend is payable July 15, 2016 to shareholders of record at the close of business on June 30, 2016. This is the Company's 89th consecutive cash dividend and represents a five-year increase of 20% over the Company's 2011 quarterly dividend.
