Lantern Pharma (NASDAQ: LTRN) is an AI company transforming the cost, pace, and timeline of oncology drug discovery and development. Our proprietary AI and machine learning (ML) RADR<sup>®</sup> platform leverages over 34 billion oncology-focused data points and a library of 200+ advanced ML algorithms to help solve billion-dollar, real-world problems in oncology drug development. By harnessing the power of AI and with input from world-class scientific advisors and collaborators, we have accelerated the development of our growing pipeline of therapies including eleven cancer indications and an antibody-drug conjugate (ADC) program. On average, our newly developed drug

programs have been advanced from initial AI insights to first-in-human clinical trials in 2-3 years and at approximately \$1.0-2.0 million per program.

Our lead development programs include one lead product candidate in a Phase 2 clinical trial and recently initiated Phase 1 clinical programs for two additional lead product candidates with potential in multiple important cancer indications. We have also established a wholly-owned subsidiary, Starlight Therapeutics Inc., to focus exclusively on the clinical execution of our promising therapies for CNS and brain cancers, many of which have no effective treatment options. Our AI-driven pipeline of innovative product candidates is estimated to have a combined annual market potential of over \$15 billion USD and have the potential to provide life-changing therapies to hundreds of thousands of cancer patients across the world.
