Pursuant to Treasury Regulation §1.1061-6(c), STORE Capital Corporation is disclosing additional information related to the capital gain dividends reportable on Form 1099-DIV, Box 2a, Total Capital Gain Distributions for purposes of Section 1061 of the Internal Revenue Code (IRC).
