The HNT portfolio acquired by StoneCalibre includes the LinkSprinter™ Network Tester, LinkRunner™ Network Auto-Tester, OneTouch AT Network Assistant, AirCheck™ G2 Wireless Tester, and AirMagnet Mobile solutions. NETSCOUT will work toward a smooth transition for customers, partners, contractors and suppliers by collaborating with StoneCalibre to provide a variety of services across a range of functional areas over the next several months as StoneCalibre completes its carve-out of HNT as a standalone company in its portfolio.
