Extra Space has more than doubled its store count since 2021.

In 2024, the company added 297 stores to its operating platform. Extra Space's property growth comes from multiple sources. Of the 4,011 stores, 49 percent are wholly owned properties, 12 percent are owned in joint venture partnerships, and 39 percent are managed on behalf of independent owners by Extra Space Storage's ManagementPlus platform.

"Since our founding in 1977, Extra Space has remained a values-driven company. This milestone reflects years of hard work and commitment from the team to our company values of integrity, teamwork, passion, innovation, and excellence," continued Margolis.
